By-Law No. 2025-10

**A BY-LAW TO ESTABLISH VARIOUS FEES AND TARIFFS FOR SERVICES
PROVIDED BY THE MUNICIPALITY OF DUTTON DUNWICH**

WHEREAS Section 69(1) of the Planning Act R.S.O. 1990 C.P. 13 as amended enables a municipality to establish fees for the processing of applications made in respect of planning matters;

AND WHEREAS the Municipal Act, Chapter S.O. 2001, Chapter 25 s.90(3) authorizes the municipality to pay for a portion of the capital cost of water works by imposing a water works rate on owners or occupants of land who derive or may derive benefit from the water works;

AND WHEREAS the Municipal Act, Chapter S.O. 2001, Chapter 25 s.391(1) authorizes a municipality to recover the costs for issuing a Tile Drainage Loan.

NOW THEREFORE the Municipal Council of the Corporation of the Municipality of Dutton Dunwich enacts as follows:

1. THAT the Council of the Corporation of the Municipality of Dutton Dunwich reserves the right to reduce or waive entirely any fee in specific cases or specific application;
2. AND THAT the Council of the Corporation of the Municipality of Dutton Dunwich hereby delegates the CAO/Treasurer, or designates, the authority in his or her discretion to waive, reduce or otherwise vary the fee or charge for the item concerned, as it is set out in this by-law.
3. AND THAT there will continue to be a "no charge policy" for service clubs, minor sports teams and non-profit clubs to use the Council Chambers for their meetings and registrations;
4. AND THAT there will be no fee charges for use of any facility to provide programs operated by the municipality;
5. AND THAT interest be charges monthly on all outstanding balances, other than property taxes, at a rate of 2% per month unless otherwise addressed in this fees by-law;
6. AND THAT By-law #2024-40, enacted by the Council of the Municipality of Dutton Dunwich is hereby repealed;
7. AND THAT this by-law shall take effect on the 1st of January, 2025.

READ a first and second time this 11th of December, 2024.

READ a third time and finally passed this 11th of December, 2024.
